ITALIAN vs AMERICAN ELECTIONS INFORMATION

In the 4th Edition 2010 of the magazine PRIMO, the editor's notes titled AN ITALIAN'S GUIDE TO CONGRESS gives a very nice comparison between the Congress of the US and Capitol Building and how they were based on the history and ideals of Italy a "model by which to build a great nation". The Capitol building was inspired by ancient Rome's Capitoline Hill the interior of which was decorated by Italians and Italian Americans, The main contributors being Constantino Brumidi, Filippo Costaggini, Enrico Causici to name a few. Two of Brumidi's works are "Apotheosis of George Washington," a tribute to the father of our country and a 19 paneled work depicting American history from Columbus' landing and ending in the birth of aviation (required two other artists to finish). The editor then comments on the structure of Congress and how in the recent elections the House of Representatives now has 28 Italian Americans and there are 6 Italian American Senators. Described is how the Congress functions, a system modeled after ancient Rome's republic. It is observed that unlike Jewish, African, and Irish Americans, Italian Americans are not wed to a single political party or cause – of the 28 Italian American congressmen there are 15 Republicans and 13 Democrats. ~JAR

ITALIAN AMERICAN COMMUNITY San Gennaro Festival in Little Italy Threatened

It all started back in January with the beginnings of an uproar in New York City's Little Italy community. Community Board #2 wanted to cancel the San Gennaro Festival! For eighty-five years this Little Italy neighborhood had been celebrating the patron Saint of Naples with food, music, dancing and the kind of neighborhood camaraderie that many of us wish we could find in our own communities today. "Little Italy" is a community in any number cities across the United States where those immigrants of Italian heritage lived together with others of their own culture.

Today, many thousands of people attend this festival located in the Little Italy neighborhood in New York City. They travel from all over our country and from Italy to celebrate heritage and pride and they also bring business to this otherwise quiet neighborhood – well, it used to be quiet until it became one of the most sought after neighborhoods for the tourists and yuppie crowds. These newcomers fight to end this celebration of Italian heritage and this is not the first Italian neighborhood to find itself under attack. The San Gennaro festival in Chicago, the Giglio Feast in the Williamsburg neighborhood of New York City and the Saint Anne's Feast in Hoboken New Jersey have all been under attack for years by those that wish to stop the noise on their streets. The San Gennaro Feast in Chicago and the St. Anthony Feast in Greenwich Village have already been discontinued because of the protests by these people.

Traditionally, all of the San Gennaro vendors were Italian but in the 1970's organizers were told they could not discriminate against other ethnic groups and today you will find vendors from all cultures. Originally, the festival was held along Mulberry Street from Worth Street to Houston but it was shortened in 1994. This year, the Community Board wants to shorten the festival by three more blocks and have it end at Kenmare Street. The movement to stop this from happening is growing faster than anyone could have predicted. One of the founders of this movement is OSIA member, John Fratta, great-grandson of the first president of the San Gennaro Society of Little Italy.

Late in January, as word came through that Community Board wanted to once again interfere with this Italian American tradition, a movement was started through social networking outlets. A Face book page called *Little Italy and San Gennaro Under Attack* has grown with hundreds of new members joining daily. People are posting from all over in favor of fighting this new ruling. Stories of their families who first settled this neighborhood are posted and you can feel the pride they have for their culture. Fratta and his supporters are asking for help as they attend Community Board meetings, make phone calls and do media interviews.

Thirty-eight board members of Community Board #2 in Manhattan NYC voted unanimously for the resolution to reduce the size of the festival itself. Included in the resolution document is: "...CB#2 Manhattan will continue to negotiate further reductions of scale and duration for subsequent years." Not only do they want to reduce the location size, but also the length of time the festival can be held because the new business owners in the area disapprove of the noise and disruption to their businesses, yet they moved their businesses into that neighborhood knowing that this festival is held every year.

The issue is now in the Mayor's office where they wait to find out the decision to be made.
