General Laws of the Order: Defaults, Cancellations and Resignations (from ART. 10)

A member is considered in arrears when such member has not paid the current dues, fines, and assessments to the Local Lodge and is in DEFAULT when in arrears for a period of three consecutive months.

The consequences of being in arrears are:

a) Loss of Bereavement Fund Benefits.b) Loss of privilege of the floor and of the right to vote.

c) Loss of the right to run for or hold office, if an officer.

The consequences of DEFAULT are:

a) Loss of Bereavement Fund benefits

 b) Shall be stricken from the rolls of membership if by the first day of the 4th month does not remove the cause of such default.

The Financial Secretary shall notify the member who is in default by mail at least 15 days prior to the date of the meeting in which such defaulting member may be declared stricken from the roll of the Local Lodge.

Reinstatement may be applied for with pre-payment of one year's dues. The member, if approved, may be reinstated and need not be re initiated and will acquire all rights and privileges extended other members after readmission.

Lodge Council Members Duties and Responsibilities

FINANCIAL SECRETARY

Source = ART. 27 of General Laws

The Financial Secretary is the collector and accountant of the Lodge. Duties are but not limited to:

a) To collect dues and assessments.

b) To write orders of payment.

c) To present orders of payment to the Treasurer, who issues checks, which checks the Financial Secretary presents to the parties to whom they are payable.

d) To make up and keep up to date financial records, particularly those entrusted to the Financial Secretary by the Grand Lodge or Supreme Lodge. Those financial records are: The ledger, financial statements, Orders of payments.

e) To notify by mail those members who are in default with the payments of dues and assessments

f) To announce members in default with the payment of dues and assessments to the assembly.

g) To communicate to assembly the total collections and disbursements made as of that meeting.

h) To make available to the Trustees the Financial Reports, Ledgers and Statements each Quarter.

 To make payment of the per
Capita Tax, computed on the basis of the number of members listed on the membership roll at the end of each quarter, which payment shall be made without the need for deliberation on the part of the assembly ,not later than 1/15, 4/15, 7/15, and 10/15 of each year.

j) To carry out all orders which the Financial Secretary may receive, in matters affecting the office, from the President and from higher ranking officers of the Order.

COMMISSION FOR SOCIAL JUSTICE (District 8 Liaison: Br. Joe Rubé)

As the District 8 CSJ (Commission for Social Justice) I would like to take this opportunity to explain the structure and workings of the Commission.

As members of the Order Sons of Italy in America, we are all considered members of the CSJ. At the State level, the Commission Chair is Lou Gallo, who presides over a committee made up of the State/CSJ President, Treasurer, Financial Sec, Legal Counsel, 14 Executive Committee members (including recently appointed Silvano Orsi from our Lodge), and the Liaison from each of the 8 Districts.

Representing District 8 (Rochester & Geneva) as Chair is myself. Each of the Lodges also has a Local Lodge Liaison – Matthew Grosodonia (VLL2270), Steve Muzzi (Geneva Men's), and Sandy Shading (GAIL Lodge).

The NY Commission for Social Justice is the anti-defamation arm of the NY Grand Lodge, OSIA. It is organized specifically to engage in the work of combating defamation of Italian Americans and others. Its two primary goals are:

1) To fight bias, bigotry, and defamation aimed at Italian Americans as well as other groups.

2) To promote a positive image of Americans of Italian heritage.

Our members are instrumental in recognizing in our own communities when there are issues that might require intervention by the CSJ organization. Examples recently brought to our attention are racial slurs by radio personalities, shows and movies that are clearly negative stereotyping of Italians and Italian Americans, etc. If you have noted an issue that you would like reported to the CSJ, the process for getting them involved is simple. Contact one of our CSJ Liaisons and provide as much information and supporting documentation as possible to be reviewed by our State CSJ Executive committee. The CSJ Chair will review the issue and supporting documentation and make a decision on whether the complaint is worthy of its support, and a plan to counter will be formulated.

The CSJ is sponsoring our current Essay Contest for Middle Schoolers, and supports our efforts to assure Italian Language Courses remain in our schools' curriculum.

2015 Italian Regional Dinner - Naples

The 2015 annual Italian regional dinner celebrates the foods of Naples and the Campania region. Americans can thank Naples for the dishes we enjoy as famous Italian -American foods: pizza, dried pasta, Spaghetti all Puttanesca or with clam sauce, eggplant parmesan, meatballs, zeppole and many Italian pastries.

Rich in historical, artistic and cultural traditions, Naples offers a distinct cuisine, influenced by the Arabs, Normans, Spaniards and French that ruled the area at one point or another. It was Naples that produced the first commercially available dried pasta and where flattened flour cakes, the forerunner of pizzas, were made out of wheat flour, olive oil, lard and herbs and garnished with cheese. The earliest use of tomatoes in Italian cuisine was documented in a Neapolitan cookbook in the late 1600s.

Neapolitan dishes take advantage of the fresh ingredients abundant in the Campania region of Italy. The region's sunny weather and fertile soil, rich with volcanic ash deposited after eruptions of nearby Mount Vesuvius, yield the exquisite flavors of its native fruits and vegetables, like San Marzano tomatoes, artichokes, eggplant, zucchini, peppers, lemons, figs, apricots, peaches, pears, grapes, almonds, hazelnuts, olives, capers, oregano. Like many other areas

With a scenic coastline along the Tyrrhenian Sea, Naples produces a rich array of seafood, large and small, including vongole (clams), cozze (mussels), shrimp, octopus, calamari (squid), sconcigli (large snails), anchovies, sardines, cod and tuna, just to name a few. Simply grilled, poached or fried, dressed with drizzle of fresh lemon and a sprinkling of parsley, Naples' daily catch makes mouthwatering plates.

While the Napolitano consume mostly seafood on a daily basis, Naples also boasts succulent preparations of meat. Among the most famous dishes are meatballs (an Italian-American classic), chicken or rabbit alla cacciatora, roasted lamb or goat with peas and potatoes, pork sausages and braciole (stuffed pork rolls) or pork liver topped with bay leaf and encased in a net of pork fat, beef steak (bistecca) or other meat (carne) slow cooked with tomatoes and known as Bistecca or Carne Pizzaiola.

Finally, desserts of the region focus on citrus and pastry. Well known Neapolitan deserts include Sfogliatelle (paper-thin layers of pastry formed into clam-shaped pockets filled with creamy ricotta cheese and bits of candied citrus), zeppole (fried dough cakes) and stuffoli (little balls of crisp deep fried dough, drizzled with honey and decorated with candy sprinkles, cinnamon-sugar or bits of orange rind).
