CSJ: Recap of 2018 From State to Local Issues Sister Marjorie Focarazzo

The Commission for Social Justice (CSJ) is the antidefamation arm of the Order. Its prime purpose is to address issues that are defamatory to Italian Americans. Its belief is no group should suffer from the vile aspirations of hate. The CSJ is committed to deal with complaints brought to its attention if the nature, scope, and degree falls within its scope.

Columbus Day continues to be an ongoing issue. More and more governmental agencies are looking to remove Columbus Day and replace it with Indigenous Peoples Day, although November has been designated as the month, with November 23rd as a specific day, for Native Americans to celebrate their contributions, history, culture, and heritage. In the spring, the State of California compromised a change to Italian American Heritage Day after confronted by the California Italian American Task Force. Downstate, Southampton Central School District has, once again, considered eliminating Columbus Day in favor of Indigenous Peoples Day in the academic calendar. A letter sent to the board of education expressed the New York State Commission for Social Justice use of unfair standards and discriminatory practices toward Italian Americans. An ad was placed in the Southampton Press to convey the CSJ's concerns with the change and to reflect tolerance and diversity.

Columbus Circle statue of Christopher Columbus was landmarked in October and cannot be moved or amended. A marker can still be added, but this may be more difficult to obtain.

It has been said that when we can no longer celebrate the accomplishments of men like Columbus, no matter his imperfections and shortcomings, then we have lost that which makes us great and unique. President Ronald Reagan said, "Columbus is justly admired as a brilliant navigator, a fearless man of action, a visionary who opened the eyes of an older world to an entirely new one. Above all, he personifies a view of the world that many see as quintessentially American, not merely optimistic, but scornful of the very notion of despair."

Oct. 8, 2018 saw Rochester mayor, Lovely Warren, issue a proclamation declaring the second Monday on October as Indigenous People's Day. Our lodge was represented at the next City Council meeting voicing our opposition of this act, reminding them November has already been deemed as Indigenous People's month. A response to CSJ Chair John Fratta, who had contacted the mayor's office was that the City of Rochester had not replaced Columbus Day and that a proclamation declaring October as Italian American Heritage Month was issued by the mayor's office and flew the Italian flag of Italy over city hall on Oct. 23rd and 24th.

New Orleans Massacre took place in 1891 with the biggest Italian lynching in American history Taking

place. The murder of police chief David Hennessey was blamed on Italians, more specifically Sicilians, who had immigrated to New Orleans. The assailants were not identified, but newspapers called the chief's death a declaration of war. Nineteen Italian men were charged with his murder. The trial declared them not guilty, but the city had been led to believe otherwise. The crowd then turned from an outraged public into a vengeful mob, as many shouted, "Yes! Yes, hang the dagoes!" The crowd rounded up the men and lynched them. No action was ever taken against the mob but, but it forced Italy to cut off diplomatic relations with the U.S. and even sparked rumors of a war.

At the National Plenary session, Chair John Fratta and NYS CSJ was asked to take the lead in contacting the mayor of New Orleans and Governor of Louisiana to obtain an apology,

Chairman Fratta has received a response from New Orleans' mayor. The mayor is inclined to release an apology. At this time, talk of a monument may be erected in a park in a minority district for remembrance purposes.

Closer to home, the Gates Chili School District in a budget reducing plan, decided to eliminate the Italian and Latin Foreign Language classes at the Middle School level, leaving no feeder into the high school programs. With the help of the community and Italian American leaders, who addressed the school board, the programs were saved which gives students more opportunities to learn Italian and learn about the Italian culture.

Complaint Policy originally drafted in November 2007 was recently reviewed with a few minor changes. The CSJ receives numerous complaints and requests regarding issues of bias and bigotry. All complaints should be put in writing including enough detail, so the issue can be identified. Once a decision is made to accept the matter, which is based on a criterion, the concern is brought to the State body for further consideration and actions.

Casa Italiana at Columbia University is not using the facility to promote Italian good. While we may not feel this concern affects us since Columbia is down state, we need to remember there is a fine line between down state and upstate. What is a possibility or even an actuality downstate can very well find its way into our own back yard.

Many issues addressed by the CSJ may not affect us demographically. They may not even affect us on a personal level. BUT if we are not willing to stand together and fight to address the wrongs now, there may be no one left to speak for us later. It is something to think about.
